This privacy policy governs the collection, storage and use of personal information collected by us, Andries Labs S.R.L, via our website at https://www.jurnyz.com. ## 2 A quick word about children

We do not and will not knowingly collect information from any unsupervised child under the age of 18. If you are under the age of 18, you may not use this website unless you have the consent of, and are supervised by, a parent or guardian.

### 3 The personal information we collect about you

• When you create an account on the Website and every time you sign in, we may collect the following information from you:

- Your name,
- Your email address,
- Your password,
- Your IP address.
- Your session identifier (automatically generated), and
- Connection time stamp.

If you do not provide your name, your email address and a password, you will not be able to create an account on the Website.

- When you are using our services, we may collect the following information from you:
  - Location of the visited place or the place you wish to visit (your "Wish List");
  - Start date and end date of the trip (only for visited location);

If you do not provide the information listed below, you will not be able to add a new location to your list of visited places or to your Wish List.

- You will also be offered the option to provide the following information:
  - Title of the trip (e.g. Holidays with Jonathan);
  - Thumbnail (cover image) for the trip; and
  - Your profile picture.

## 4 How we may store and use your information

We may collect, store and use your personal information listed above for the following purposes:

- to make this Website available to you;
- to provide you with services that you request;
- to ensure the proper functioning of the Website (including, to process your comments / opinions, to analyse your usage of the Website, to contact you about the Website, for the management of your requests relating to your right of access, rectification, opposition and the use of your personal data after your death, to improve the Website and the services we offer. to resolve disputes, to deal with complaints and to correct operational problems);
- where you have given us your consent, to contact you (including by e-mail) with products and services which we think may interest you.

We may also use your Wish List to provide you with tailored content such as hotel and transportation advertising.

We will not disclose, sell or rent your personal information to any third party unless you have consented to this. If you do consent but later change your mind, you may contact us and we will cease any such activity.

However, if a third party acquires all (or substantially all) of our business and/or assets, we may disclose your personal information to that third party in connection with the acquisition.

We may also disclose your personal information where we are required to do so by applicable law, by a governmental body or by a law enforcement agency.

### 5 Retention period

We keep your personal data as long as your user account is active and during three years after your last login to your account or after your last contact with us.

### 6 Sharing your personal information with other users

The Website is designed to help you share information about the place you visited or wish to visit with other users/web users. Therefore, you agree that other users may have access to your name, email address, profile picture, list of visited places, descriptions and pictures of your trip, Wish List, list of users you follow and users who follow you.

When you create a new location (place visited or wished to visit), you will have the possibility to make confidential any information and/or pictures you enter about a location. At any time, you can change the visibility level of a location by accessing the settings.

Any user will have the possibility to search for other users by their e-mail or by their username, see their lists of visited places, follow them, share your list of visited places with non-registered users, and embed their map of visited places in another webpage.

## 7 Commercial communications and opt-out

We may send you administrative emails (emails regarding changes in the operation of the Website, in this Privacy Policy etc.) and, subject to your prior consent, emails containing advertising and information regarding our products and services.

You can request not to receive non-administrative emails by contacting us at contact@jurnyz.com or using the unsubscribe link at the end of each message you received.

### 8 Recipients of personal data and transfers

We can send your personal information to service providers who support our business (computing providers and logistic partners, including hosting provider).

Your privacy is important to us. That is why we decided to host your personal information on servers located in France. However, to manage and develop the Website, we may access your personal information from the Republic of Moldova, where our company is established. When creating an account, you expressly consent to the transfer of your personal information to the Republic of Moldova.

Please be aware that the Republic of Moldova which is outside the European Economic Area may not offer the same level of protection for your personal information although our collection, storage and use of your personal data will continue to be governed by this privacy policy.
